Sub: Benefits of E-nomination facility to the members – Request for dissemination of information – Reg.

As you are aware, the Employees' Provident Fund Organisation has identified 'e-nomination of EPFO subscribers,' as an important activity under the Azadi Ka Amrit Mahotsav (AKAM) to simplify the claims process for its subscribers. This is in the backdrop of commemorating 75 years of India's Independence. In this context, it is brought to your kind notice that EPFO has already introduced an online facility to file nominations for its members, known as 'e-Nomination'. The members are required to file the e-nomination for availing of multiple social security benefits. The benefits of E-nomination are as follows:

- ✓ Self-declaration-is sufficient. No approval is required from the employer.
- ✓ Paperless claim process with no need to visit the EPFO office or attestation by the employer.
- ✓ Online Pension claim can be filed.
- ✓ Expeditious settlement of Member Pension Claim.
- ✓ Speedy and online settlement of EPF, EPS, and EDLI claim to the eligible nominee(s), in the unfortunate event of the death of a member.
- ✓ E-Nomination can be changed at any time as per the wish of the member.
- ✓ It can be traced easily at the time of claim settlement.
- ✓ Probability of return of claims will be less. (Approximately 35% of death claims were returned due to issues with nominations during 2021-2022, which could be easily avoided by filing the e-Nomination).

In view of the above, you are advised to disseminate the information on the benefits of e-nomination and facilitate the filing of e-nominations by your employees (members) immediately. E-nomination enables the nominee or dependents to withdraw funds accumulated under the Employees' Provident Fund (EPF), Employees' Pension Scheme (EPS), and Employees' Deposit Linked Insurance Scheme (EDLI) in the event of the account holder's demise in a hassle-free manner.

Your cooperation in this regard is highly solicited.
